Service scope of Nagarro ES VAT registration check

- Automatic address acquisition and virtually 100% positive check results*.
- The archiving of check results received is carried out in conformity with legal requirements.
- Depending on country (of the company code), the check is completed from the official page of the Federal Central Tax Office or the European Commission (VIES/MIAS).

Master data check: Customers / vendors / business partners

- Customer, vendor or business partner master data are automatically checked when they are created as soon as one or more VAT registration numbers are saved.
- A check is performed automatically when creating or modifying qualified fields (name, street, house number, postal code or city) or the VAT registration number.
- The check results for the relevant master data are automatically archived in SAP in PDF form and also in an analyzable log table. Master data mass checks can be run using various selection options.
- The results of these checks are displayed in an ALV grid report. Download to MS Excel is supported.

Order and invoice check

- Depending on country, sales organization as well as order and invoice type, all VAT registration numbers are automatically checked in orders and invoices.
- The check results are made available through an ALV grid control report, here also download to MS Excel is supported.
- All check protocols are saved in a table and are available at any time.

Customizing

- The activation switch is used to activate or deactivate the VAT registration check for the following application areas: customers, creditors, business partners, order creation and invoices.
- In case of negative check results, we are flexible in supporting your process configuration.
